Smoke Detector (SD) & Carbon Monoxide (CO) Alarm Requirements

When the valuation of addition(s), alteration(s), or repair(s) to dwelling units exceeds \$1,000.00, the following requirements are applicable:

- If not present already, smoke detectors shall be installed in each sleeping room, and outside each separate sleeping area in the immediate vicinity of the bedrooms, and on each additional story of the dwelling, including basements and habitable attics as required by Section R314.6 of the 2010 California Residential Code and Section 907.2.11.2, 420.4, of the 2010 California Building Code and CA Health and Safety Code § 13113.7.
- For dwellings or sleeping units containing fuel burning appliances or having attached garages, carbon monoxide detectors shall be installed outside each separate sleeping area in the immediate vicinity of the bedrooms, and on each additional story of the dwelling, including basements as required by the 2010 California Residential Code § R315.2 and Section 420.4 of the 2010 California Building Code. Multipurpose (combination carbon monoxide and smoke) alarms may be used per California Residential Code § R315.31 and California Building Code § 907.2.11.2.
- In addition, if the work is new construction or addition, the alarms must be hard wired (110 volt) with battery back-up and all alarms are to be interconnected per 2010 California Residential Code § R314.4, R314.5, R315.1.1, R315.1.2 and 2010 California Building Code § 907.2.11.3, 907.2.11.4, 420.4.1.1, 420.4.1.2.
- All alarms shall comply with requirements for UL listing and approved by the Office of the State Fire Marshal.
